- 4. Reports on progress since last meeting
 - February presentation to Board of Trustees (Sarah & Kirsten)
 - o presented 3 resolutions
 - Green Fleet Policy framework to increase efficiency and phase in electric vehicles - Approved Feb 28th
 - Energy Benchmarking visibility into energy usage of Village owned buildings and plans for more efficient usage - Approved Feb 28th
 - Green procurement policy through NY state to ensure items are the most efficient and sustainable where possible confirmed that will be adopted in April with annual purchasing policy
 - Food scraps program events, schools, Village e-blast, apartment buildings

- Recycling
 - o We need more bins and standardize
 - Jared advised that there are new ones that combination see Hudson & Beekman
 - they have signs showing what goes in each one
 - o Anne would like to see a survey of where there are recycling bins and where they are missing
 - Update the ones that are messy
- Communications (Kiko & Bill)
 - o .com versus .org & sponsored content
 - working on seeing if we can be a .org to avoid advertising
 - o website upgrades still to be confirmed by BOT
- CEC grant & CAP grant process (Sarah)
 - o CEC awarded 2 x \$5k grants which will go towards electric landscaping equipment
 - lawnmower, leaf blowers, battery replacements
 - we would like to do a press release once equipment arrives
 - just have to run it by NYSERDA before publishing
 - o CAP
 - Char & Sarah will have a call with DEC administrator and hopefully have a consultant within the next few months
 - There is overlap with the NYForward grant projects (Jared)

 - o Recycling labels ask the DPW if they can include in budget request
 - o Recycling bins
- Fremont Pond Restoration Project (Dave)
 - o Village looking for contractor for bioremediation
 - 5 RFPs public input is not being sought for contractors
 - o on the BOT agenda 07-Mar to choose a contractor / project management
 - Stakeholders will be instrumental in making the project successful including the board of education

- Expecting that the contractor will contact the list of people / stakeholders of Fremont Pond
 - The 2 Manor associations the SH Manor association was notified by Dave
- Anne will attend the work session
- Waste Reduction education campaign (Gina)
 - o move forward with the flyer about the waste stream and will have a subcommittee meeting
- Westchester County Waste Management program review (Anne)
 - o Requested the BOT to sign up for a consultant on the incinerator
 - o set up a meeting with Lou Vetrone waste management commissioner for Westchester for this Friday the 10th
- Char suggesting recommendations for Westchester zero waste
 - o Where do the solids go from the Yonkers wastewater treatment plant?
 - Overflow at SH goes into the Hudson River at Horan's landing
- Complete Streets policy & pedestrian safety Walkable Tarrytowns (Anne)
 - Elizabeth working on a survey to rank the safety of intersections in the 2 villages
 - Both critical routes & safety of each intersection
 - o Anne going to create a walk using a QR code for people to vote on
 - State roadway versus village roadway
 - o Pulling off of the complete streets policy that were passed in both 2014 for Tarrytown and 2016 for SH.
 - Amendments are needed for both of them
 - o Jared it is going to be very important to have Tarrytown & SH be in sync on their goals
 - Senator Andrea Stewart-Cousins got funding for Route 9 redesign from Hastings to the Old Dutch Church in SH.
 - Very important that the villages are aligned and advocate, otherwise Dept of Transportation will do a conventional plan
 - Organizations like Livable Tarrytowns and everyone that is interested needs to come together and pitch the game plan targeted towards Empire State Development & the governor's office - they can direct the Dept of Transportation
 - We have some leverage because of the housing compact and the Rivertowns are almost united against the Governor's housing plan. The governor is creating coalitions on how affordable housing is built so we need to use this opportunity for rte 9 streets

- o 6 of the 10 major intersections in SH have been selected for pilot programs
 - Jared will share the details via email
- Anne Reaching out to school boards and others to gain more interest

 - Climate emergency

- Jared thinks we should take a position on it and SHEAC/CSC should bring it to BOT
- Pocantico Hills development proposal with stormwater runoff
 - o Village administrator advised SHEAC of the same as above

 - the next public hearing is 30-Mar at Mt Pleasant Town Hall
 - looking for more people to attend
 - SavePocanticoLake.org
 - unincorporated Mt. Pleasant (Not Briarcliff)
 - construction will bring a lot of blasting to the location that is a direct tributary to the Pocantico River
 - The conservancy has weighed in but more people are needed
 - Jared SHEAC / CSC should pitch to the board to have them take a position
 - "We have concerns about the proposal"
 - Pocantico Lake is a county park
 - Reason why it is not outside of our purview
 - Downstream overflow
 - No discussion on downstream
 - what happens to the land that clears stormwater
 - what happens in the 100 year storm
 - The process to file showing that SH is a key stakeholder because we are downstream of both Pocantico Lake and the Indian Point

8 - Open comments

- NYSERDA will pay a Climate Fellow out of a disadvantaged community to work full time on a program that we are discussing here (we would need to apply for this program)
 - o we can promote this to everyone particularly people of color and those in a disadvantaged community
- Sewer overflow
 - o Model program at Syracuse "Save the Rain"
 - Syracuse county had to avoid sending water to a site, they looked at the entire city and created green infrastructure to reduce stormwater flows
 - restoring wetlands
 - bioswales
 - We have a combined sewer

- overwhelms yonkers wastewater treatment plant and the sewer main
- the gate is at Horan's landing for overflow which is triggered when treatment plant is overwhelmed
- We need to bring education to people & need to redirect our storm water since we have a combined sewer
 - o the Fremont pond initiative will work on this for that location
- Sarah what does the process look like to act on this?
 - Education campaigns
 - o Storm water
 - o Rain gardens
 - o dry well
 - Kirsten will look at CSC points for this
- Scarsdale implemented dry wells requirements
