 - iii. Sarah suggested that we incorporate this with Earth Day at Barnhart
 - iv. Also something at Peabody later with larger volume
- 6. We will need updated outreach materials
 - a. Self standing Signs 3x6 that can go behind the booth "Instant Booth"
 - b. Ideally using green purchasing policy
 - c. Will have a separate conversation about the design
- 7. Schedule Waste Reduction Subcommittee meeting
- 8. WASS Sign-on Letter / Incinerator Research (Anne)
 - a. Laura Burkheart has done a lot of research for the Peekskill Incinerator "Wheelabrator" research
 - i. Summary is showing that there is no viable alternative to wheelabrator
 - ii. New technologies have downsides, landfill is not a clear alternative with less emissions
 - iii. Laura the EPA updated their guidelines to become more stringent and Wheelabrator standards were updated in 2020 that surpass EPAs suggestions
 - As a downside The plant does generate ash as a byproduct which has to be taken to a landfill. However, looking at research the plant in Peekskill is the least bad
 - 2. WASS claimed that incinerators have more emissions than landfills however it depends on the emissions you are evaluating, landfills emit large amounts of methane

- iv. The age of the burner does not determine the emissions, the upgrades are important and we would like to see a review of the air quality in the area since the upgrades.
- b. Gina WASS has drawn the conclusion that Wheelabrator needs to be closed however the idea of a zero waste consultant we should support
- c. Anne we would like to propose getting a zero waste consultant.
- d. Gina we can have an impact on producing less feed for the incinerator but the incinerator will run through the end of the contract
- 9. Climate Action Plan RFP update (Sarah)
 - a. Proposals are due Wednesday and we need to select within a month
 - b. Please sign onto the RFP subcommittee
- 10. Energy Benchmarking next steps (Sarah)
 - a. Working on starting with the energy software, will need to enter utility data
- 11. LED Streetlights update (Kirsten)
 - a. It is a work in progress. They are out for RFP and we are speaking with the DPW on the color scheme of the lights. We are pushing for a more amber colored light versus white/blue for animal and human impact
- 12. Green Infrastructure Policy Ichabod's Landing Bulkhead (Judi)
 - a. The riverfront pavement has to be added and in some cases redone
 - b. We can petition as CSC/SHEAC for the village for permeability of surfaces
 - c. Dave Along Kingsland waterfront they are building in a rocky shoreline with a seawall component
 - i. The east parcel has to include permeable pavers to help protect the historical Philipse Manor
 - d. Anne what about people with mobility issues and strollers, bikes

16. E-Bikes (Char)

- a. There is currently a proposal for a ban because of possible fatal fires from the lithium-ion batteries
- b. Speaking with companies and other municipalities for outdoor lockers so that bikes can be stored and charged outside of buildings
- c. If we want to encourage people to bike then we need to support e-bikes because of the hills in our village
- d. Hoping to get people at the Edge onboard
- e. Looking for SHEAC support to help mitigate carbon emissions
- f. Once battery technology is improved we are confident they will be safe again and in the meantime we want to push for cleaner air. Additional Details below

The Fortnightly Club of Sleepy Hollow and Tarrytown invites you and your family to a special lecture by River Keeper Chief Habitat Manager George Jackman, Ph.D. on the sturgeon in the Hudson River.

Every time you cross the Tappan Zee or Bear Mountain Bridge, there is a chance that a fish older than you (and three times as tall) is swimming under you. The Hudson River is home to two species of endangered sturgeon, species that have survived from the time of the dinosaurs despite all that development along the Hudson has thrown at them. As well as being aggressively hunted throughout the 19th and early 29th C as "Albany beef." We are pleased to hear from Riverkeeper's Senior Restoration Habitat Manager George Jackman, Ph.D. about these amazing living fossils.
