Introductions

- 1. Community Choice Aggregation (Westchester Power)
 - a. Background
 - i. Opt for renewable energy option for CCA
 - ii. Contract coming to an end and the village needs to decide if will renew
 - iii. Community Choice Presenting to BOT with an Memo of understanding (MOU) on July 2nd
 - iv. Has been controversial topic so would like SSH to give a recommendation
 - v. Controversy includes opt out vs opt in so you are automatically enrolled
 - vi. Supply Rate is fixed for the terms of the contract which will compare to the Con Ed rate
 - 1. This last year ConEd prices were lower so people are upset
 - 2. They feel confident that this year renewable rate will be better
 - 3. This is more competitive than another renewable ESCO
 - 4. Low income households are not enrolled so as to avoid disproportionate expenses
 - vii. We can also opt in to 50% green but don't know the rates
 - viii. We can also re-enroll for 100% and find out what the price differences will be
 - ix. Renewable power has been hydro before and now incorporating solar and wind
 - b. Sarah will check what happens if individuals already have solar
 - c. The village gets CSC points if we 100% opt in
 - d. SSH supports continuing 100% because it is climate smart. Unless it becomes price prohibitive
 - i. This gives more choice to customers, not less
 - ii. It is a continuation
- 2. CFA Grant Consolidated Funding Application Grant
 - a. How can we apply for funding to implement the CAP?
 - i. Must be practical, is beneficial to the village, and gets CSC points
 - ii. Hire an engineer to do a community wide study on green infrastructure to reduce stormwater impact and reduce flooding creating a "sponge city"
 - 1. This idea earns up to 14 pts and is practical and beneficial going hand in hand with Complete Streets
 - 2. Could be VHB because have all the data

- 3. Could take 1-2 years
- 4. Capital expenditure that we may be able to match with NYF money that will be applied to Cortland streetscaping
- 5. Can apply "in kind" services meaning the grant pays for village employees
- iii. Own the solar at Elm street to generate electricity and revenue for the village
 - 1. This project could reduces the tax bill by 2%
 - 2. Could take 3 years to see the benefit
 - 3. Also gets CSC points between 9-20
 - 4. Difficult because requires capital investment partner to remediate the site
- b. Grant application due at the end of July
- c. Fiona presented on possible grants. Martin will forward the presentation
- d. Sarah will work with CAP to submit information to Fiona for grant application

3. River Cleanup Event Grant

- a. Partner of Riverkeeper American Rivers we applied for free trash bags from them for the cleanup
- b. Char filled out the feedback afterwards and then we won a \$2500 grant to clean the river
- c. Want to focus on Health of the Hudson, set a foundation for sustainable impact, include students, educate the public, work with partners: Sewage testing at Horan's Landing and have a monthly river sweep before the water testing
- d. May be able to get some "citizen scientists" or will use Riverkeeper for consistency
- e. Testing costs \$50 / test
- f. Next step: Char will have a meeting with Riverkeeper to discuss organize and logistics next week
- g. Would like to have enough information to recruit volunteers at the mermaid festival
 - i. Work on bringing in the other organizations including studies on Fremont pond, peabody preserve to evaluate water quality

4. Logo Redesign update

a. Melissa is starting work on them

- a. Riverkeeper is going to have water testing and river education
- b. Local artist to display art with plastic
- c. Gina creating signup genius for volunteers
- d. Needs bins and recycling bins Kirsten & Kiko to follow up with Kevin on logistics

8. Solar installation CEC grant update

- a. Solar for on top of village hall using the roughly \$90k awarded to SH
- b. The village has a grant to fix the roof so can combine the funds
- c. Placement is on the southern exposed side of the roof so captures more light hours

9. Leaf blower restrictions update

- a. Signs have gone up but slow to implement the ban
- b. It has gone into newsletters
- c. Need more ways to implement
- d. Start discussing with BOT to ask police to start implementing fines for homeowners and raise revenue for the village
- e. Short messages to have people follow the rules

10. Buddy bench

- a. Follow up on WI's "buddy bench" to have plastic drop off with the village/DPW
- b. Kendal is starting this in September
- c. The HS is considering the same for the school year
- d. We just have to request a Terra Cycle box
- e. The plastics are very high in phthalates that even if changed into benches then still emits high levels of estrogen
- f. Revisit at next meeting

11. Turf field - Village & WI update

- a. Susanne wrote to Brian Fried asking what the school district is researching and explained the letter we shared with BOT
- b. Followed up with Dean at TEAC to ask if there was similar discussion

- c. Our letter was sent to BOT 3 trustees are adamantly wanting artificial
- d. Environmental lawyer could possibly present to BOT on expected general litigation that they are seeing
- e. Barnhart is causing problems and is due for replacement along with discussion for new fields at East Parcel
- f. Susanne will reach out to Dr. Audrey Brutus who is educating at Saturday Academy

12. Community Gardens update

- a. Susanne meeting with Margie and other gardeners working on Statue Island and deciding protocol on how to work with the group
- b. meeting every other Thursday morning for the time being
- c. How is the BOT being informed? Anthony and Matt Arone are in the loop
- d. Matt has attended

13. Friends of SH non-profit

- a. Active committee on garden maintenance/friends of the parks
- b. Mayor discussing with legal counsel on how to implement and set up so have independent organization
- c. Will create the ability to fundraise
